- **5. CONSENT CALENDAR** A. Approval of July 15, 2024 Regular Meeting Minutes; B. Approval of July 2024 Revenue and Expense Report; C. Review of 2023-2024 fiscal year final Budget Status, Trial Balance and Endowment funds. A motion was made by Boardmember Dodini, seconded by Boardmember Robinson approving the Consent Calendar as received. The motion passed 4-0.

Review Grasshopper Mower Quote from Baker Supplies and Repairs Chairman Engell requested that the Board approve the purchase of two Grasshopper mowers instead of one due to the age and number of hours on the District's existing mowers that are past their useful life. A motion was made by Boardmember Dodini, seconded by Vice Chairman Jones to approve the purchase of 2 Grasshopper Mowers from Baker Supplies and Repairs not to exceed the quoted amounts of \$22,904.03 for the Grasshopper Model 325D and \$25,630.01 for the Grasshopper Model 725DT. The motion passed 4-0.
